# yLead Travel Adventure Booking Terms and Conditions

## 1. ACCEPTANCE AND AGREEMENT

The yLead Association Inc. (yLead) offers The Applicant a place on the Travel Adventure on the strict understanding that The Applicant has read and understood this and the following Booking Conditions and accepts and agrees to abide by them. Once accepted the Applicant becomes a yTraveller.

## 2. HEALTH AND FITNESS REQUIREMENTS

It is the obligation of each yTraveller to ensure that he/she is in good health prior to the Travel Adventure, having regard to the destination and undertakings of the Travel Adventure. Each yTraveller confirms that he/she has answered the questions on the Registration Form accurately and agrees to promptly inform yLead in writing if any of the information supplied becomes incorrect before the scheduled departure date.

## 3. DOCUMENTATION AND LEGAL COMPLIANCE

Each yTraveller is responsible for obtaining and having available the necessary documents including visas to enable him/her to participate in the Travel Adventure and agrees to comply with all legislation, customs, immigration rules and other regulations of the countries through which the Travel Adventure shall pass.

## 4. INSURANCE

yLead requires each yTraveller to take out comprehensive travel insurance to include emergency, casualty evacuation, compensation for loss or damage to certain property or possessions and public liability. The cost of insurance is included in the adventure fee. yTravellers are responsible for taking out additional insurance if required.

## 5. PRICES AND EXTRAS

The price quoted includes all specialist equipment supplies, administration and travel arrangements both internal and external for Travel Adventures with the following exceptions:

- (a) Each yTraveller is responsible for arrangement and payment of all his/her costs for domestic flights to, and returning from, the Australian departure city, inoculations, passports, visas, tips and airport taxes where required.
- (b) Each yTraveller is responsible for providing his/her own prescribed medical requirements, personal equipment and clothing as advised and detailed under the appropriate sections of the Travel Adventure information and any supplementary written communications or instructions sent to yTravellers.
- (c) Travel Adventure costs are based on ground costs, airfares and exchange rates at the time of application and may be subject to fluctuations. yLead endeavours to maintain its advertised price but reserves the right to increase this price without notice at any time up to and including the day of departure of any Travel Adventure in the event of exchange rate fluctuations, increases in fuel costs, airport charges, airfares or increases in ground operator service fees.
- (d) Each yTraveller is responsible for emergency evacuation charges.

## 6. CANCELLATION

Each yTraveller acknowledges that he/she has been provided with travel insurance that may cover cancellations in some but not all circumstances. For all cancellations the following fees apply per yTraveller:

- i) Prior to 180 days before departure – total loss of deposit
- ii) Between 180 days and 90 days (inclusive of those days) prior to departure - total loss of deposit and 50% of any subsequent payments made.
- iii) Less than 90 days prior to departure and after commencement of travel - total loss of Travel Adventure fee including deposit.

## 7. VIABILITY OF TRAVEL ADVENTURE

Where there are a number of cancellations or other circumstances arise beyond the reasonable control of yLead so as to make the Travel Adventure in the opinion of yLead no longer viable, then yLead shall;

- i) in the case of cancellations be entitled to treat all yTravellers of that Travel Adventure as having cancelled his/her participation in the cancelled Travel Adventure
- ii) use its best endeavours to join those yTravellers who wish to participate with another yLead Travel Adventure.

## 8. ALTERATIONS TO DESTINATIONS, ITINERARY, TRAVEL ADVENTURE LEADER, ETC.

Where circumstances arise such that in yLead's opinion it is necessary or advisable to make alterations to the destination or departure date of a Travel Adventure and/or changes to itinerary, routes, length or dates of the Travel Adventure, identity of the Travel Adventure leader(s), then yLead shall be entitled to make any or all of such alterations and changes without prior notification to or consultation with the yTraveller.

## 9. AUTHORITY OF THE LEADER

yTravellers agree that they will abide by the decisions of the Travel Adventure leader or leaders engaged by yLead whilst a Travel Adventure is in progress.

## 10. RIGHT OF WITHDRAWAL

yLead reserves the right to withdraw any yTraveller at any time and the Travel Adventure leader may, at any time require any yTraveller to leave the Travel Adventure in circumstances in which yLead determines the continued presence of the yTraveller prejudices the Travel Adventure's good order or discipline whether involving contravention of the law of any country through which a Travel Adventure passes or otherwise.

## 11. TRANSFERABILITY

This contract is personal to each yTraveller and/or their parent or legal guardian who shall not assign the benefit of this Contract without the prior written consent of yLead.

## 12. FLIGHT ARRANGEMENTS

yLead makes all decisions in the planning process of the Travel Adventures. This includes without limitation decision making as to the identity of the operator, the aircraft flight number, departure date, and arrival destinations.

## 13. INDEMNITY

Each yTraveller and parent or guardian acknowledge that the enjoyment and excitement of the Travel Adventure is derived in part by travel and activity involving risks beyond the safety of life at home or work. Each yTraveller and parent or guardian accepts all the inherent risks of the Travel Adventure and all activities associated or ancillary thereto.

By signing the booking form the Applicant or where the Applicant is under the age of 18 years his/her parent or legal guardian agrees to be bound by the conditions set out in this agreement. Applications will only be accepted if the booking form is signed by both the Applicant and his/her parent or legal guardian. The Applicant and where the Applicant is under the age of 18 years the parent or legal guardian of The Applicant must carefully note the contents of Travel Adventure information (which may include a code of conduct) provided by yLead and The Applicant and parent or guardian must note and comply with the joining and other instructions set out in the Travel Adventure information. Failure to do so may prejudice other yTravellers, yLead and Travel Adventure leaders causing consequential losses and expenses for which the parent or guardian of the yTraveller will at all times hereafter indemnify and keep indemnified yLead and its employees.

Each yTraveller and where the yTraveller is under the age of 18 years the parent or legal guardian of the yTraveller will at all times indemnify and keep indemnified yLead, its employees and Travel Adventure leaders against all liabilities incurred by any or all of yLead, its employees and Travel Adventure leaders, the yTraveller and his/her parent or legal guardian by reason of any of the following:

- a) Failure to ensure the yTraveller is in good health as set out in clause 2 of this agreement.
- b) Failure to have necessary documentation as set out in clause 3 of this agreement.
- c) The yTraveller being withdrawn from the Travel Adventure as set out in clause 10 of this agreement.

Except to the extent that the Trade Practices Act and the Fair Trading Act imply non-excludable rights into this contract, the yTraveller and his/her parents or guardian waives any and all claims he/she may now or in the future have against yLead, its employees and Travel Adventure leaders, and releases from all liability and agrees not to sue yLead and its employees and Travel Adventure leaders.

## 14. PROPER LAW

This Agreement shall be governed and construed in accordance with the laws in force in Queensland for the time being and the parties hereby submit to the exclusive jurisdiction of the courts of that State.
